This is an online tender, where only e-Tender will be accepted and no offline/hard copies will be accepted.

- 1. Tender Processing Fee and Earnest Money must be sent in the form of demand draft in favour of ICAR UNIT, DSR, Mau by offline in the name of *Director, ICAR-Indian Institute of Seed Science, Kushmaur, Mau 275103 (UP)* on or before Bid Submission End Date and time positively by post, otherwise respective tender is not entertained.**
2. The tenders are liable to be ignored if complete information as required is not given therein or if the particular asked for in the schedules to the tenders is not fully filled in.
3. The terms and conditions of the contract which will govern any contract made are those contained in the General conditions of contract applicable to the contracts placed by the ICAR and by the Research Institutes of the Council and the special terms and conditions are detailed in the tender forms and its schedules. Please submit your rates in the tender form if you are in a position to furnish the requisite services in accordance with the requirements stated in the attached schedules.
4. An earnest money of **Rs. 1, 20,000/- (Rupees One Lakh twenty thousand only)** must be deposited in the form of demand draft payable to **ICAR UNIT DSR, Mau at Maunath Bhanjan**. Scanned Copy of the Earnest Money Deposited must be uploaded in the Tender, failing which the tender will not be opened. Conditional Bids shall not be considered.

5. The tenderer is being permitted to give tenders in consideration of the stipulations on his part that after submitting his tenders, he will not resile from his offer or modify the terms and conditions thereof. If the tenderer fails to observe and comply with the foregoing stipulation, the aforesaid amount of EMD will be forfeited by the Institute. Information provided at this stage is indicative and ICAR-IISS, Mau reserves the right to amend further details in the tender document.
11. Before filling up the Tender, firms/agencies are advised to go through the Tender Paper thoroughly and accordingly fill up the contents thereof, as per the norms of Tender. After submission of the tender, no request for any alteration is permissible. Non-compliance of any of the Terms & Conditions of the tender shall make the Bid liable to be rejected, calling for no exception/further request in this regard.
12. **Dispute Resolution Mechanism:** If any dispute or difference arises between the agencies/firm and ICAR-IISS, Mau relating to any matter connected with the contract, the parties shall make every effort to resolve the same amicably by mutual discussions. However, if the parties fail to resolve the dispute or difference by such mutual discussion within 30 days, either the purchaser or the supplier may give notice to the other party of its intention to refer the same to arbitration. The

arbitration shall commence thereafter. The arbitration shall be conducted by a sole arbitrator, who will be appointed by the Secretary, ICAR and the procedure to be followed in this respect will be as per the Indian Arbitration and Conciliation Act 1996. The venue of the arbitration shall be the place from where the contract is issued.

13. An amount of **Rs. 300000/- (Rupees Three Lakhs only)** as a Security deposit for the contract in the form of D.D/FDR is to be deposited by the selected agency/ successful tenderer only after receiving a communication from the Institute. In the event of non-deposition of the same, the earnest money will be forfeited. If during the validity of the Contract, the tenderer expresses his inability to continue with the quoted rates or asks for enhancement, the security deposit shall be forfeited and no request in this regard shall be considered. The institute may also take additional legal action against the defaulter. No interest on security deposit and earnest money deposit shall be paid by the Institute to the tenderer.

14. The Institute will not be held responsible for any sort of postal delay received after stipulated date & time as specified above shall be deemed as summarily rejected.

- 19.** The tenders are liable to be ignored if complete information as required is not given therein or if the particular asked for in the schedules to the tenders is not fully filled in. Individual signing the tenders or other documents connected with the contract may specify whether he signs it in the capacity of (i) a sole proprietor of the firm or constituted attorney of such sole proprietor, or (ii) a partner of the firm if it be partnership in which case he must have authority to refer to arbitration dispute concerning the business of the partnership whether by virtue of the partnership agreement or power of attorney or (iii) constituted attorney of firm, if it is a company.
- 20.** The scope of work shall include the upkeep and maintenance of the Layout preparation, Weeding, Hoeing, Earthing, Irrigation and Harvesting etc. by Tractor/ Power-tiller/ Vehicle, Generator set, Pump set, Electric tube-well, Gardening, the work related to Laboratories and upkeep & maintenance of the Office and Lab. Building. The small items like spade, khurpi, hansia and kudal, etc. will be arranged by the Firm/ Contractor itself. For mechanized work- Tractors and its related implements will be provided by IISS, Mau. Care has been taken to include all the expected crops and works. - 22.** The Monthly Wages of the Contractual Labors engaged by the firm will be paid in accordance with the Minimum Wages Act and instructions issued by Ministry of Labour from time to time. - 23.** GST or any other tax applicable or made applicable after awarding the contract in respect of this contract shall be payable by contractor and the Institute will not entertain any claim whatsoever in this respect. However, the Income tax or any other tax which is as per the rules of the Govt. of India shall be deducted at source from monthly bills of the successful tenderer, as per rule/ instructions made applicable from time to time by the Govt.

2. The tenderer is being permitted to give tenders in consideration of the stipulations on his part that after submitting his tenders, he will not resile from his offer or modify the terms and conditions thereof. 3. Only those firms will be considered for opening of the financial bid which will qualify in the technical bid. In case, any deployed worker of the contractor suffer by any type of injury while performing any duty, the contractor will be wholly and solely responsible to meet the claims made by such employee for medical expenditure and or expenditure incurred for rehabilitation and IISS, Mau would have no liability towards damages claimed by such employee. Any statutory benefits of any sort to the deployed person of the contractor under any Act or law of the time being in force would be the sole liability of the Contractor and not that of the IISS.
12. The workers so provided by the agency/contractor under this contract will not be treated as employees of the IISS and there will be no employer-employee relationship between the IISS and the workers so provided.
13. The contractor is bound to maintain the services of the deployed personnel in the contract. 18. The contractor or his workers will abide by rules & regulations of IISS, Mau and maintain good discipline and decorum.
19. The contractor will provide and maintain specified FIRST AID BOX at the premises and observe rules and laws as required by Contract Labour (R&A) Act, 1970 and Contract Labour (R&A), Rules, 1971 and as amended from time to time.
20. The successful Contractor/Agency will have to enter into an Agreement Deed on Stamp Paper for execution of job contract on the above terms & conditions of the contract.
